# FY23 Draft Tentative Budget

T. Rancak, chief business school official, reviewed the changes to the FY23 draft tentative budget. She shared the tentative FY23 budget must on display for at least 30 days prior to the board meeting and a notice of the Public Hearing must be published in accordance to the Illinois School Code Requirements.

### FY22 Resolution to Authorizing the SSP through TRS

Ms. Rancak shared that the school district attorney has recommended that the district adopt the Employer Participation Agreement Resolution. She reviewed that in 2018, the Illinois legislature amended the Illinois Pension Code to add a requirement that the Teachers Retirement System (TRS) provide an optional defined contribution benefit to all eligible members of TRS beginning in 2021, which is known as the TRS Supplemental Savings Plan ("SSP"). Discussion was held on the topic.

#### FY23 D75 & D76 IGA School to School Lunch Agreement

Ms. Rancak reviewed the recommendation to approve the intergovernmental agreement for food services with District 76. She shared the benefits that both districts and students would share. Discussion was held on the topic.

# 2022 IASB Joint Annual Conference

Dr. Myers inquired which of the board members would be interested in attending the IASB Annual Joint Conference in Chicago that is scheduled on November 18-20, 2022. Discussion was held on the topic.

# Annual Review of Safety Drills
