FY24 Budget for Adoption & Resolutions

T. Rancak, chief school business official, reviewed several areas from the FY24 budget. Discussion was held on the topic.

National School Lunch Program Bid

Ms. Rancak reviewed the recommendation to award the lowest bidder: Arbor Management, Inc. the school lunch program for a period of one (1) year, with the option to renew for four (4) additional one-year periods.

Intergovernmental Agreement with Mundelein Park District

Ms. Rancak reviewed the recommendation for the district to approve the updated intergovernmental agreement with Mundelein Park & Recreation District. The IGA will permit the park district to lease space to develop and operate a before school, non-school day, after school, and summer camp programs for students. It will also include updated transportation rates, invoicing methods currently in place, and automatic annual renewals.

Construction Management Savings

Ms. Rancak reviewed the recommendation for a stipend to be paid to the Directors of Facilities and Maintenance. She also reviewed the additional responsibilities for managing construction projects at the district. The stipend would be paid over two years for additional time worked outside of their normal work duties to operate as in-house construction managers. Discussion was held on the topic.

FY24 Administrator & ESP Compensation

Ms. Rancak reviewed the recommendation for salary increases for non-MEEA employees for FY24. Discussion was held on the topic.

Public Relations Update

Peter Gill, director of public relations, reviewed the social media channels the district utilizes to share the many activities in the community and schools.

Federal Grant Application Process

Dr. Sarah Cacciatore, assistant superintendent of student services, reviewed the consolidated district plan for the district. She shared how the grant funds are utilized by the district.
